

Membership Application & Service Agreement

As defined in the Fair Credit Reporting Act (FCRA), a consumer report is a report that consists of any written or oral communication of any information pertaining to a person's credit worthiness, credit standing, credit capacity, character, general reputation, personal characteristics or mode of living, if this information is used for the purpose of serving as a factor establishing a consumers eligibility. Therefore, I hereby certify to AmeriCheckUSA the following;

I have received a copy of "Obligations of Users Under the FCRA" and "A Summary of the Consumer's Rights under the FCRA".

Consumer reports will be obtained for the sole purpose of determining prospective employees eligibility.

Before every consumer report is requested, the consumer has authorized in writing that they authorize the procurement of their consumer report.

The information from the consumer report will not be used in violation of any applicable Federal or State equal employment opportunity law or regulation.

Before taking any adverse action based in whole or in part of a consumer report, the person intending to take such adverse action shall provide to the consumer to whom the report relates (1) a copy of the report; and (2) a copy of "A Summary of the Consumer's Rights under the FCRA".

I will not disclose consumer reports, in whole or in part, to any third party.

I will restrict the number of personnel who have access to consumer reports.

I will develop and follow a security plan to protect the confidentiality and integrity of consumer reports.

I will develop and follow procedures to ensure that consumer reports are protected throughout their entire information lifecycle (from email transformation, use, storage and secure destruction) regardless of the media used to store the data.

I acknowledge my responsibilities under the Fair Credit Reporting Act.

I acknowledge my responsibilities for access security.

I certify that I am the end user and will not further sell the consumer reports.

Failure to comply with the FCRA can result in State or Federal enforcement actions, as well as private lawsuits. In addition, any person who knowingly and willfully obtains a consumer report under false pretenses may face criminal prosecution.

The customer further agrees to release AmeriCheckUSA, it's officers, and agents or employees from any claim or loss that may occur to the customer through consumer reports furnished. The customer agrees to indemnify, defend and hold AmeriCheckUSA harmless from any claims or lawsuits arising out of the information given.
